Finding His Way

— Jeremiah's Journey

"I can't do it! What if I fall?" Jeremiah cried out, gripping the ropes course with shaky hands. At just seven years old, the thought of being suspended in the air without clear sight was overwhelming. "I'm scared! Someone come get me!" he shouted. That year, fear won — but it wouldn't win forever.

A year later, Jeremiah was back, this time with more determination. With encouragement from his instructors at Lighthouse Central Florida, he stepped onto the course again. He listened, trusted, and pushed forward—this time, making it to the end. By his third year, he barely needed guidance. "Jeremiah doesn't let his visual impairment stop him," says Maria, one of his instructors. "He's always willing to try, no matter what."

Lighthouse's Children's Program teaches essential life skills, but it also fosters independence through real-world experiences. Monthly field trips, like the ropes course, help students build confidence, improve mobility, and prove to themselves that they are just as capable as their sighted peers.

Today, Jeremiah is a leader among his friends at Lighthouse.

He's learning to type — already reaching 22 words per minute and mastering skills like meal prep and packing a suitcase. His mother has seen his confidence soar. "For kids with vision loss, Lighthouse is their light," she says. "It helps them see their own potential."

Coming Full Circle

— Addison's Journey

Addison's journey with Lighthouse began when she was just a toddler. Every Wednesday, Miss Erin would visit her home, guiding her through fun, hands-on activities that felt like play but were actually building critical skills for her future. "We'd go on ball hunts in macaroni, pick tiny objects out of pockets, and feel different textures," Addison recalls. "It was fun, but it was also preparing me for life."

After "graduating" from the Early Intervention Program in kindergarten, Addison reconnected with Lighthouse at age eight through the Children's Program. In a small but growing group, she learned life skills, teamwork, and even some meal prep lessons that would serve her well in the years ahead.

As a teen, she joined the Transition Program, where the focus shifted to real-world independence. Though the pandemic disrupted her planned work experience, she still attended the Life On My Own virtual camp, gaining knowledge on budgeting, job exploration, and navigating public spaces with confidence.

Now, Addison is taking her next big step — **working at** Lighthouse Works while pursuing her dream of becoming a mental health counselor. From a young child learning through play to a working professional, Addison's journey has come full circle. "Lighthouse showed me how to find my way and believe in myself," she says — now, she's helping others do the same.

Building a Future

— Grayson's Journey

For Grayson Peddie, technology isn't just a career — it's a lifelong passion. From an early age, he was drawn to Information Technology (IT), always eager to solve problems and build systems that worked seamlessly. After completing the National Industries for the Blind's Cisco Network Academy and earning his Cisco Certified Network Associate (CCNA) certification in 2024, he set his sights on a role that would combine his technical skills with his drive to make a difference. That's when he discovered Lighthouse Works.

Starting as an accessibility tester in the Digital Accessibility Services department (now Technology Solutions), Grayson quickly made an impact. He not only mastered the fundamentals of accessibility audits but also went above and beyond, studying Web Content Accessibility Guidelines (WCAG) in depth and even surpassing some of his more experienced colleagues in certain areas.

But Grayson didn't stop there. His passion for efficiency and automation led him to develop the Tech Solutions Audit Machine (TSAM), a tool designed to streamline testing and improve workflow for auditors. Though a side project, he built TSAM with scalability in mind, envisioning a future where it could serve an entire team.

Outside of work, Grayson continues his IT journey — earning certifications, refining his home lab, and exploring Linux, Windows Server, and 3D modeling. **At Lighthouse, he's not just shaping his career** — he's shaping the future of tech accessibility.

Finding Purpose

— Junior's Journey

When Junior Beureuse lost his vision due to severe kidney issues, his world was thrown into uncertainty. He had once thrived in contact centers, but now, with his health failing and no clear path forward, he struggled to see a future for himself. That changed the day a nurse introduced him to Lighthouse Central Florida.

Determined to rebuild his life, Junior enrolled in rehabilitation programs, relearning essential skills. He started with typing courses, working tirelessly to regain independence. When he discovered Lighthouse Works' contact center training program, everything clicked. The industry was familiar, and for the first time in years, he felt a renewed sense of purpose.

Despite financial hurdles, Junior refused to give up. He paid out of pocket to attend training, showing up every day with unwavering commitment. His dedication paid off — after six months of perseverance, he landed a job at Lighthouse Works. But this was just the beginning.

Junior quickly rose through the ranks, from agent to instructor and now a Quality Analyst. He mentors new hires, fosters a supportive work environment, and even assists with Creole language assessments to improve recruitment. His journey is one of resilience and determination. **Today, Junior stands as a leader, proving that with hard work and belief in oneself, any obstacle can be overcome.**
