Officials with Lighthouse Works say their efforts to enter the LED lighting sector have been bolstered by the excitement surrounding the Green Works Orlando initiative. The City driven initiative is a series of community and municipal plans meant to transform Orlando into one of the most environmentally, economically and socially vibrant communities in the nation.

"We're proud to stand alongside the great sustainability team at the City of Orlando, in their efforts to increase energy efficiency within and beyond our local communities," said Nasehi.

Lighthouse is particularly interested in the Better Buildings Challenge, which sees the City of Orlando undergoing \$17.5M of energy efficiency upgrades to 56 municipal facilities, including lighting upgrades, HVAC renovations, building automation and controls, and other cost effective energy conservation measures.

Works will also focus on identifying large-scale, commercial contracts and GES will be responsible for auditing a building's current energy consumption and installing the energy efficient lights accordingly.
